If returned by mail, the ballot must be postmarked no later than Election Day, for counting no later than during the period for counting provisional ballots, the last day of which is the 14th day following Election Day.

I understand that by making an application for permanent vote-by-mail status I will automatically receive an official vote-by-mail ballot to be voted by me at any subsequent election that I am eligible.

I understand I can remove myself from the permanent list at any time by contacting my local election official. I further understand that any changes to my registration address will require me to reapply to the permanent vote-by-mail list.

Under penalties as provided by law pursuant to 10 ILCS 5/29-10, the undersigned certifies that the statements set forth in this application are true and correct.
